

Portfolio attributes

- This is a concentrated fund holding approximately 30-35 shares that are listed on the South African equity market.
- The investment approach is industry, style and size agnostic, providing exposure to a broad array of small and mid-sized companies.
- The fund is managed by fundamental valuation-based equity investors with a highly active approach to portfolio management.
- The proprietary research generated by a team of equity specialists.
- The benchmark is used in portfolio construction primarily as a final risk management tool.

Investment manager

- Electus is an independent business owned predominantly by staff, with complete business and investment autonomy and extremely limited potential for conflicts of interest.
- They are focussed entirely focused on equity investing, with an unbroken 17 year track record.
- The founders of the company have extensive experience analysing stocks across the entire South African equity market.
- The company has enjoyed stable and persistent success, with a very attractive long-term, risk-adjusted return relative to the market and competitor funds.

Investment philosophy

- The fund manager begins with all JSE-listed shares and narrow the investable universe with a bias to shares demonstrating a sufficient level of liquidity.
- They systematically evaluate each share, utilising both absolute and relative valuation methodologies.
- They follow an unconstrained investment style, with flexibility to move actively between industries, sectors or themes.
- Portfolio construction is important given the concentrated ultimate list of holdings.
- They remain optimally positioned to capture excess return generating opportunities, within a risk-managed framework.
