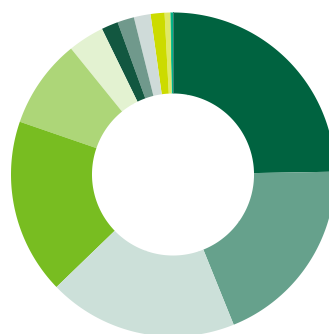

Portfolio attributes

The investment manager will endeavour to unlock the liquidity risk premium embedded in money market assets via the structuring and purchasing of assets that will create yield enhancement over the life of the asset within the fund.
