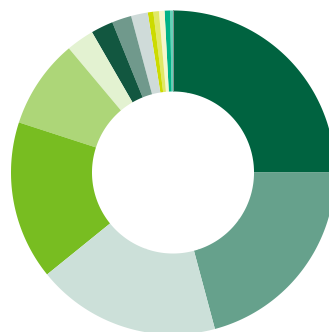

Portfolio attributes
